

REGISTRATION POLICY – EUROMECH 2026 – Colloquium 670

All participants must be registered. If the maximum attendee capacity is reached, the conference organizers reserve the right to refuse any registration.

1. EUROMECH member:

Membership, as required by EUROMECH, is mandatory to register for the Colloquium. The registration fee of each non-member participant includes an EUROMECH contribution (€ 30).

2. Students:

Student fees are applicable only to full-time students. Students must be able to provide a proof of their student status (student ID card or certificate).

3. Substitution:

If you are unable to attend the conference, you can request the transfer of your registration to another participant by notifying the conference secretariat before the conference.
